05 He also visits various graduation and post graduation colleges to impart training to faculties for their skills development.


02 He is a visiting faculty to many degree and post degree colleges in providing CS career awareness orientation to the students on behalf of ICSI, Hyderabad Chapter.

04 He has been delivering knowledge on various subject matters under Companies Act, 2013 before various branches of ICAI across the states of Telangana and Andhra Pradesh.


